

Terms and conditions of The Food Warehouse Worcester Ballnado Competition ("Competition")

1. By entering the Competition, entrants are deemed to have accepted and be bound by these terms and conditions.
2. The promoter is: Iceland Foods Limited of Second Avenue, Deeside Industrial Park, Deeside, Flintshire CH5 2NW (the "**Promoter**").
3. To enter the Competition entrants must attend The Food Warehouse store at Blackpole Retail Park, Blackpole Road, Worcester (the "**Store**") on Tuesday 14th October 2025 between 08:00 – 14:00 and enter the Ballnado experience located at the Store. No purchase is necessary to enter.
4. During the Ballnado experience, entrants will be required to grab the whirling balls within a 30-second time limit. Entrants that grab a minimum of fifteen (15) balls and are holding them in their hands by the end of the 30-second period will be a winner of the Competition.
5. The Competition will be judged by a member of the Ballnado experience crew. The decision of the crew member (acting reasonably) will be final, and no correspondence or discussion will be entered into.

13. By entering this Competition, entrants and any winners agree to participate in any reasonable publicity required by the Promoter in relation to the opening of The Worcester Food Warehouse store.

Insofar as is permitted by law, the Promoter, its employees or agents will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of participating in the Competition or from accepting the Prize except where it is caused by the negligence of the Promoter, its agents or employees. Your statutory rights are not affected.

16. The Competition is governed by the laws of England and Wales and is subject to the exclusive jurisdiction of the courts of England and Wales.
